## **PUBLIC COMMENT:** No Comments.

Mr. Szabo opened the meeting with the Pledge of Allegiance and thanked everyone for attending.

At this time, Mr. Szabo introduced Steve Colabufo, who updated the Commission regarding the State of the Aquifer Report.

Mr. Szabo then introduced Mr. Wallach who discussed outreach in order to promote the Public Hearings.

Mr. Szabo introduced Ken Zegel, Associate Public Health Engineer, SCDHS, Office of Ecology, who discussed the Suffolk County Subwatershed Plan.

Next, Mr. Szabo discussed the Wastewater Treatment Report – Task 3A for the Groundwater Management Plan. Mr. Milazzo stated that the proposed Task 3A report, which is the Wastewater Management in Nassau and Suffolk Counties, has been distributed. This report is H2M's original product with input from Suffolk County and the LICAP staff. H2M issued the report and want LICAP members to receive it, review it and approve it to make it LICAP's Report. Mr. Milazzo stated that today's assignment is that the Members should discuss Wastewater Management issues in Nassau and Suffolk County, or if there are no issues, then accept this report and move on to the other three. Mr. Szabo asked for comments at this time.

Mr. Szabo then referred to Other Business and introduced Mr. Motz who discussed creating an internship program for the Our Water Our Lives Campaign. Mr. Motz recommended that LICAP have two interns provide social media content about the Campaign. Mr. Motz introduced Assistant Professor David Taylor from Stony Brook University's Sustainability Studies - Marine Science Program, who discussed this proposal, at length. The Commission further discussed obtaining an intern from Hofstra, as well.

At this time, Mr. Szabo discussed funding which is due from Nassau and Suffolk Counties to the Commission.

Mr. Motz further updated the Commission regarding the Our Water Our Lives Campaign.

Mr. Szabo took questions/comments from the Public audience.
